APPLICATION FOR NO-COST HOME ENERGY ASSESSMENT

For households with incomes that falls within the levels specified below, NJNG maybe able to perform a no-cost home energy assessment provided the customer meets the eligibility criteria for NJNG's Repayment Program. Customers may then be able to pursue HPwES energy-efficiency upgrades with generous incentives through NJCEP. Eligible customers can apply for up to \$15,000 in financing, including a 0% APR On-Bill Repayment Program option, and may be eligible for up to a \$4,000 rebate based on total energy savings achieved. Terms and conditions apply.

- If your household income exceeds the maximum shown, you will not qualify for the no-cost assessment from NJNG, but you can still apply for the generous incentives available for energy-efficiency upgrades. NJNG Repayment Program Requirements:

The Repayment Program is offered to NJNG customers for owner-occupied single family and duplex homes. Qualified NJNG residential customers can repay between:

- \$2,500 and \$10,000 of the approved cost of their HPwES project at 0% APR on their NJNG bill for seven years. Financing between \$10,001 and \$15,000 at 4.99% for 10 years is facilitated through Concord, a third-party loan servicer.**
- In addition, customers may be eligible to receive a \$2,000, \$3,000 or \$4,000 rebate based on total energy savings.

There are no fees, no closing costs and no prepayment penalties.

Current NJNG customers must have 12 months of on-time account payments.

- There can be no more than two instances of payments received more than 30 days after due date.
- A bankruptcy within the past 10 years in an automatic disqualifier.

**For example: A \$10,000 repayment with an APR of 0% and term of 7 years, customer would make 83 payments of \$119.05 and one final payment of \$118.85. A \$15,000 repayment with an APR of 4.99% and a term of 10 years, customer would make 120 payments of \$159.02.
