2009 PROPERTY TAX FACT SHEET

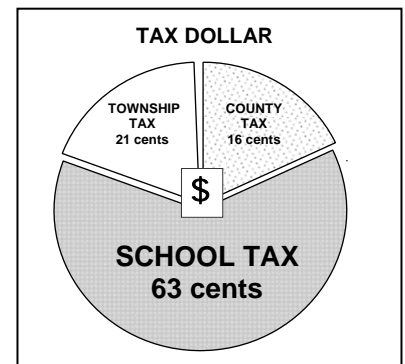
Please note the 2009 tax rate went down proportionately to compensate for the overall increase in assessed values that occurred as a result of the state and county-mandated revaluation. The new tax rate was developed by dividing the township's total tax levy by the value of real property in Middletown.

Your total property tax bill is the result of a combination of three different and distinct budgets. For every taxpayer dollar received, 63 cents goes to the school district and 16 cents goes to Monmouth County. The remaining 21 cents goes to the township.

The township budget is the only portion of the total tax bill that the governing body controls. Middletown has done its part by reducing the budget by \$1.32 million compared to last year. Many important community services are funded through the township budget including:
