Mayor Settembrino, attended Belford Engine Co. and mentioned Dr. Thompson's donation of medical kits and the ability to have more life saving devices on the trucks. He mentioned the new traffic light at Kings Highway and Church street that was fully funded by the County. Congratulations to Committeewoman Snell and to Deputy Mayor Fiore.

PUBLIC COMMENTS:

Elizabeth Polmaroy, Burlington Avenue, said she was glad the Township joined the Microgrid competition. She supports the Microgrid and the two bills A1902 and S1611 property assessed clean energy lien program. Requests bicycles and pedestrian friendly intersection at Kings Highway and Route 35.

Emily Wiggen, 42 Hosford Avenue, discussed water issues she has been dealing with for three years.

Township Engineer Ted Maloney stated that Hosford, Bryant and Leonard Avenue have drainage issues and they are looking at several easement components and doing survey work.

Steven Louis, 18 Tatum Drive, objects to the process of the most significant development by Village 35 and is concerned decisions are being made by appointed officials not elected officials.

Mayor Settembrino responded the seat are filled by the statutory laws.

Steve, 304 Florence Road, complained about intrusive cameras pointed at his house by his neighbor.

Township Administrator Anthony Mercantante responded there is no state law and therefore the Police or Township can do anything to stop it. He suggested filing a claim in Municipal Court.

Monica Manning, 36 Spruce Drive, objects to the process the Township Committee took on the Village 35 process.

Mayor Settembrino, responded he cannot comment due to the lawsuit. Without the lawsuit they could hold public meetings.

Township Administrator Anthony Mercantante said the traffic study is not complete, they still need to meet with the Department of Transportation.

John Sheffield, 59 Kings Highway, inquired about the redevelopment ordinance and discussed a PILOT program.

Township Administrator Anthony Mercantante discussed the redevelopment plan.

Cathy Rogers, 141 Wilson Avenue, commented that the Township Committee has done an excellent job keeping taxes down.

Candace Cade, 508 Locust Point Road, requested information on the review of the ordinance and what does the ordinance involve?

Deputy Mayor Fiore, discussed the control over the size and landscaping.

Leo Christofili, Cranberry Court, asked the Committee to consider a resolution to address the bonding on the State referendum on the November ballot.

Sue Griffin, Holland Road, stated it is impossible for the schools to budget with the removal of the State Aid. She thanked the Township Committee for their support.

Michael DiCicco, 46 Alexander Drive, objects to the process of the redevelopment of the Village 35 property. He asked the PILOT be done and make the developer put it to the education side.


