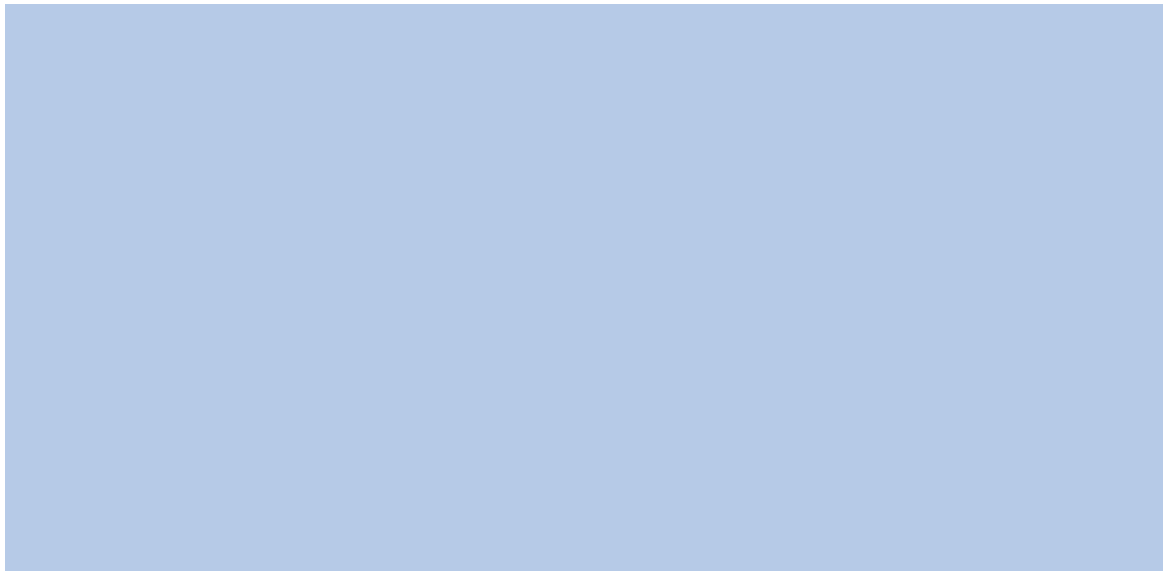

## Major Changes to July 7, 2020 Primary Election

Monmouth County Clerk Christine Giordano Hanlon is advising all voters that Governor Murphy announced major changes to the July 7, 2020 Primary Election process. This comes after the initial change in the Primary Election date from June 2<sup>nd</sup> to July 7<sup>th</sup>, announced last month.

According to Executive Order No. 144, all active registered Republicans and Democrats will automatically receive mail-in ballots for voting in the 2020 Primary Election. All registered unaffiliated voters will receive

a mail-in ballot application so that they can apply to receive mail-in ballots for voting.

### A Message From Middletown Township Animal Control:

***Please Do Not Disturb or Feed Fawns***

**Middletown Township has an extremely large population of deer. As spring has approached, so has the season when deer give birth. It is becoming increasingly common for our residents to find a fawn laying in their yard. This is perfectly normal. The mother deer has "placed" that baby there because she feels that it is safe.**

In most cases, the fawn is placed there in the morning and the mother will return in the evening, but remains relatively nearby. Just because the mother cannot be seen, does not mean that the baby is abandoned. There is no need for the fawn to be removed. In fact, the fawn should not be handled for any reason or even approached.

## NJ Residents with a Positive or Negative COVID-19 Test: Instructions and Next Steps



### NJ Residents with a Positive COVID-19 Test: Instructions & Next Steps

Question	Instructions
<b>I tested positive for COVID-19. What should I do now?</b>	<p>If you tested positive, you must stay at home and self-isolate. This means stay in a different bedroom from others in your home, and if possible, use a separate bathroom. You must self-isolate for at least 3 full days (or 72 hours) have passed since you had a fever without the use of fever-reducing medications <b>AND</b> other symptoms are greatly improved <b>AND</b> at least 10 days have passed since symptoms first started.</p> <p>If you live with other people and they were not tested, they should keep their distance from you. This includes not eating meals together and not sitting around the house together. Practice social distancing as much as is possible (stay at least 6 feet from each other).</p>
<b>What should the people who live in my home know/do?</b>	<p>If they are <b>symptomatic</b> (sick; have COVID-19 symptoms), they should also <b>self-isolate</b> for 3 full days (or 72 hours) until they are fever-free without the use of fever-reducing medications <b>AND</b> other symptoms are greatly improved <b>AND</b> at least 10 days have passed since symptoms first started. If the symptoms are mild, they should recover at home. If the symptoms worsen and a medical evaluation is needed, call health care provider.</p> <p>If they are <b>asymptomatic</b> (not sick; have no COVID-19 symptoms), they should <b>self-quarantine</b> for 14 days <b>AFTER</b> any sick person in the household's self-isolation period ends. If the asymptomatic person develops symptoms, they should follow the self-isolation instructions above. Symptoms may take 2-14 days to appear. It is important to monitor their health long enough to ensure they do not develop symptoms.</p>
<b>What is the difference between mild and moderate symptoms?</b>	<p>Mild symptoms are when you feel unwell but can stay home and manage at home. Most people with mild symptoms can recover from home. See above for how long you should stay home/self-isolate.</p> <p>Moderate symptoms are those where you may need a medical evaluation from your health care provider. If your symptoms worsen over time and do not get better, especially if you have trouble breathing, call your health care provider to determine next steps.</p>
<b>Should I tell other people that they may have been exposed to the COVID-19 virus?</b>	<p>Those who have been closest to you for a prolonged period of time are going to be at highest risk. Household members and others with whom you spent a prolonged period of time (more than 10 minutes) within 6 feet of you, or shared a meal, would be at increased risk and should be advised to self-quarantine at home for 14 days <b>AFTER</b> your, or any sick household members self-isolation period ends. If the asymptomatic person develops symptoms, they should follow the self-isolation instructions above.</p> <p>People who you did not spend a prolonged period of time (less than 10 minutes) within 6 feet are at lower risk. This would include people that you may have been in an indoor space for a prolonged period of time. They should monitor their health; no restrictions about where they go. They should wash hands often and practice social distancing. If possible, you should notify individuals above regarding your illness. Work or school supervisors may be informed to help with this process.</p> <p>People who you may have casually come into contact with (e.g., passed by in the hall, briefly spent time within a room, shared a short elevator ride), are not considered to be at risk and do not need to be contacted.</p>

**Ill NJ Residents who Tested Negative for COVID-19: Instructions & Next Steps**

Question	Instructions
<b>I tested negative for COVID-19. What should I do now?</b>	If you tested negative for COVID-19, the recommendation is to stay home and practice social distancing until 72 hours after your fever has ended without the use of fever reducing medications and other symptoms improve. After this time, you may resume regular activities. It is recommended that everyone wears a face covering when in public spaces. This protects you from anyone who may not be sick (but might be asymptomatic) and able to spread the virus to others.
<b>What if I tested negative but still feel sick?</b>	If you test negative for COVID-19 but still have symptoms, it is likely you may have another respiratory virus. You should continue to self-isolate yourself from others, practice good hand hygiene and clean and disinfect surfaces in the home. If your symptoms worsen or don't get better after several days, you should call your health care provider.  You should not return to work/school or go to public places until 72 hours after your fever has ended without the use of fever-reducing medications and other symptoms have improved. Wear a face covering if you are out in public.
<b>What other actions should I take to protect my health?</b>	As long as the virus that causes COVID-19 is spreading in your community, continue to practice social distancing, wash hands often and avoid touching your face, and clean and disinfect high-touch surfaces daily in household common areas (e.g. tables, hard-backed chairs, doorknobs, light switches, remotes, handles, desks, toilets, sinks, phones). Wear a face covering when in public places. This protects you from anyone who may not be sick (but may be asymptomatic) and able to spread the virus to others.

**Beaches & Boardwalks Reopen on May 22 with Social Distancing Measures in Place**

Per Executive Order 143, Governor Murphy permitted the reopening of all public and private beaches, boardwalks, lakes and lakeshores effective 6:00 a.m. on May 22, 2020 with certain parameters. While bathrooms, showering and
